We are aware of the impact our operations have on sustainability – the environment, society, and the economy – and are committed to playing our part in delivering increasingly sustainable outcomes through our commitments and plans. We have therefore adopted and incorporated all the United Nations Sustainable Development Goals (UN SDGs) in our key themes below.

Our Approach

- **Decarbonisation** of our estate via carbon emissions reduction and sustainable procurement.
- **Engagement of all our stakeholders by the** use of our platform to inform, educate and inspire sustainable behaviours.
- **Communication** using our mediums to promote our actions and generate further awareness of sustainable initiatives to all our stakeholders and the wider community.

- **Partnerships** including the meaning of partnership; types of partners; understanding and optimising the added social value partnerships with supply chains, the community and charities creates; and relationship building for equality, peace and justice and sustainable cities, and innovation
